### **7B. RESOLUTION NO. 010/2018**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA") APPOINTING CHRISTINA CRESPI AS THE ACTING EXECUTIVE DIRECTOR OF THE MIAMI DDA RETROACTIVE TO APRIL 5, 2018; DELEGATING THE ANNUAL REVIEW COMMITTEE THE AUTHORITY TO DETERMINE AND SET THE APPROPRIATE COMPENSATION FOR THE ADDITIONAL DUTIES.
