A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ACCEPTING THE EXECUTIVE DIRECTOR'S RECOMMENDATION, ATTACHED AND INCORPORATED AS EXHIBIT "A," OF BLOCK BY BLOCK, LLC, A FLORIDA LIMITED LIABILITY COMPANY ("BLOCK"), AS THE TOP RANKED FIRM TO PROVIDE AMBASSADOR SAFETY AND HOSPITALITY SERVICES ("SERVICES") IN RESPONSE TO REQUEST FOR PROPOSALS NO. 18-19-02; FURTHER AUTHORIZING THE EXECUTIVE DIRECTOR TO NEGOTIATE AND EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH BLOCK FOR SAID SERVICES IN AN AMOUNT NOT TO EXCEED SIX HUNDRED FIFTEEN THOUSAND DOLLARS (\$615,000.00) FOR THE FIRST YEAR AND SIX HUNDRED TWENTY-FOUR THOUSAND (\$624,000.00) FOR THE SECOND YEAR WITH UP TO THREE (3) ONE-YEAR OPTIONS TO RENEW AT AN ESCALATION RATE OF UP TO THREE PERCENT (3%) PER YEAR; FUTHER AUTHORIZING THE EXECUTIVE DIRECTOR TO NEGOTIATE A PROFESSIONAL SERVICES AGREEMENT WITH THE SECOND RANKED FIRM, UNIVERSAL PROTECTION SERVICE LLC, A FLORIDA LIMITED LIABILITY CORPORATION D/B/A UNIVERSAL SECURITY SERVICE, SHOULD NEGOTIATIONS WITH BLOCK PROVE UNSUCCESSFUL.
