### 7A. APPROVAL OF MINUTES - October 25, 2019

### **7B. RESOLUTION 029/2019**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA"), WITH ATTACHMENT(S), URGING THE UNITED STATES ARMY CORPS OF ENGINEERS ("USACE") TO MODIFY THE MIAMI-DADE BACK BAY COASTAL STORM RISK MANAGEMENT STUDY ("BACK BAY STUDY") TO INCORPORATE CHANGES THAT REFLECT MIAMI DDA PRIORITIES, INCLUDING BUT NOT LIMITED TO COORDINATING THE STUDY WITH OTHER USACE STUDIES IN SOUTH FLORIDA; SHIFTING PLACEMENT OF THE PROPOSED FLOODWALL AND SURGE BARRIERS TO MAXIMIZE THE PROTECTION OF PROPERTIES IN EDGEWATER, THE CENTRAL BUSINESS DISTRICT, AND BRICKELL AND ENSURING FLOODWALL DESIGNS ARE HARMONIZED WITH EXISTING LAND DEVELOPMENTS; AND ENCOURAGING GREATER ACCESS TO BISCAYNE BAY; DIRECTING THE BOARD SECRETARY TO TRANSMIT A COPY OF THIS RESOLUTION TO THE OFFICIALS NAMED HEREIN.

### **7C. RESOLUTION 030/2019**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA"), URGING THE FLORIDA LEGISLATURE TO AMEND THE UNDERGROUND FACILITY DAMAGE PREVENTION AND SAFETY ACT (THE "ACT") TO REPEAL PREEMPTION OF MUNICIPAL REGULATION OF MARKINGS ASSOCIATED WITH EXCAVATION AND DEMOLITION ACTIVITIES, BY PROVIDING LOCAL GOVERNMENTS THE ABILITY TO (1) REQUIRE THE USE OF AND DEFINE "TEMPORARY, NON-PERMANENT PAINT" AS USED IN THE ACT, (2) REQUIRE REMOVAL OF THE MARKINGS FROM PUBLIC STREETS AND SIDEWALKS BY THE EXCAVATORS UPON COMPLETION OF THE WORK IN THE MARKED AREA, AND (3) CREATE A CLEAR ENFORCEMENT MECHANISM ALLOWING LOCAL GOVERNMENTS THE ABILITY TO ENSURE THAT MARKINGS MADE PURSUANT TO THE ACT ARE TEMPORARY AND ARE TIMELY REMOVED.

#### **7D. RESOLUTION 031/2019**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA") APPROVING A SPONSORSHIP GRANT IN THE AMOUNT OF TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) AS WELL AS A CREDIT TOWARDS IN-KIND ENHANCED SERVICES NOT TO EXCEED A TOTAL AMOUNT OF EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00), ALL AS TO BE DISPERSED ACCORDING TO THE SCHEDULE PROVIDED IN EXHIBIT "A", TO SWARM INC. FOR THE BAYFRONT HOLIDAY VILLAGE EVENT TAKING PLACE IN BAYFRONT PARK LOCATED IN DOWNTOWN MIAMI; FURTHER AUTHORIZING THE EXECUTIVE DIRECTOR TO NEGOTIATE AND EXECUTE AN AGREEMENT, IN A FORM ACCEPTABLE TO THE CITY ATTORNEY, FOR THE PURPOSES STATED HEREIN.

### **7E. RESOLUTION 032/2019**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA") ACCEPTING THE RESIGNATION OF ALYCE ROBERTSON ("ROBERTSON") AS EXECUTIVE DIRECTOR OF THE MIAMI DDA EFFECTIVE DECEMBER 31, 2019 UPON EXECUTION OF A SEPARATION AGREEMENT AND GENERAL RELEASE ("AGREEMENT"); AUTHORIZING THE ENGAGEMENT OF ROBERTSON AS A CONSULTANT AT HER CURRENT SALARY TO ASSIST THE MIAMI DDA WITH THE TRANSITION TO A NEW EXECUTIVE DIRECTOR; AUTHORIZING THE DEPUTY DIRECTOR TO EXECUTE THE AGREEMENT AS WELL AS ANY AND ALL OTHER NECESSARY AGREEMENTS, ALL IN FORMS ACCEPTABLE TO THE CITY ATTORNEY, FOR THE PURPOSES STATED HEREIN.
