A RESOLUTION OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA"), BY UNANIMOUS AFFIRMATIVE VOTE. 4D. RESOLUTION 005/2020
